# Preston Reservoir Swimming Club Fees

In summary there are 3 types of fees involved with the swimming club. They are as follows:

**1. Swimming Victoria Fee** - this is an annual registration fee charged by the governing body. It covers the cost of insurance for swimmers, coaches and the club. Swimming Victoria also use the funds to provide resources to assist clubs in policy development and training as well as provide various programs and support for swimmers, particularly those that qualify for state and national championships. This fee is applicable for each financial year period that a swimmer is registered with a club. Swimmers pay full fee if they join the club between 1 July and 31 March and a discounted fee if they join the club between 1 April and 30 June. The full fee will be liable again in July for the start of each new financial year.

## **2018/2019 Swimming Victoria Fees**

Competitive Swimmer (15 years and under)	\$130
Competitive Swimmer (16 years and over)	\$117
Recreational Swimmer (15 years and under)	\$117
Recreational Swimmer (16 years and over)	\$107

**2. Squad Training Fee** - This fee covers the cost to pay our coaches and to hire the pool lanes for the term. This fee will be liable at the start of each term and parents will be advised of the fee from the Booking Officer.

**3. Competition Fees** - Competitions are held with swimmers from other clubs and at other venues. Competitions have fees for entering the competition (to cover pool hire and venue staff costs) as well as fees to cover the cost for any of our coaches to attend the event to supervise and mentor our swimmers. These fees will vary depending on the type of competition and its duration. An email will be sent by our Competitions Co-ordinator advising of the available competitions and their fees.
